All required initiative training must be completed between July 1, 2022 and June 30, 2023. All training costs are funded by the ELCNC.

Training is accessed and delivered through four approaches: (1) product keys, (2) MyTeachstone subscriptions, (3) ZOOM classes, or (4) ELCNC in person classes. Courses accessed with product keys and MyTeachstone subscriptions are on demand (self-paced) courses that are delivered online, whereas zoom and in person classes are live trainings that can **only be accessed during scheduled training times**. Make-up classes are not available.
