ATTACHMENT I

BONUS INITIATIVES ELIGIBILITY REQUIREMENTS AND TRAINING SCHEDULE

Training is accessed and delivered through four approaches: (1) product keys, (2) MyTeachstone subscriptions, (3) ZOOM classes, or (4) ELCNC in person classes. Courses accessed with product keys and MyTeachstone subscriptions are on demand (self-paced) courses that are delivered online, whereas zoom and in person classes are live trainings that can **only be accessed during scheduled training times**. Makeup classes are not available. All required initiative training must be completed between July 1, 2022 and June 30, 2023. All training costs are funded by the ELCNC. Applicants must provide proof of training completion for the Health and Safety Bonus. For all other Bonus Initiatives, the ELCNC will verify completion of training through appropriate training information systems.

RECRUITMENT BONUS: Eligible teachers and directors (hired on or after July 1, 2022) receive a \$500 bonus upon completion of background screening and 120 hours of employment.
